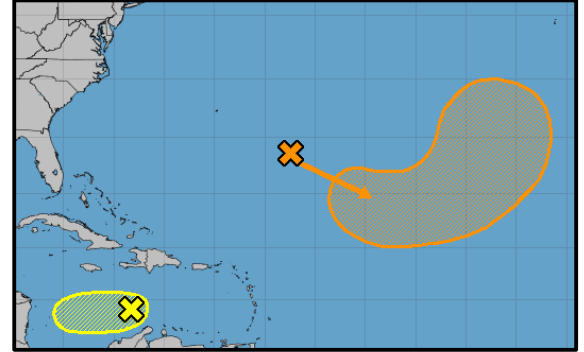
Tropical Activity

Atlantic – Disturbance 1

- Located over the central Caribbean Sea.
- Development not likely.
- Formation chance – 48-hour: Low (10%); 7-day: Low (10%)

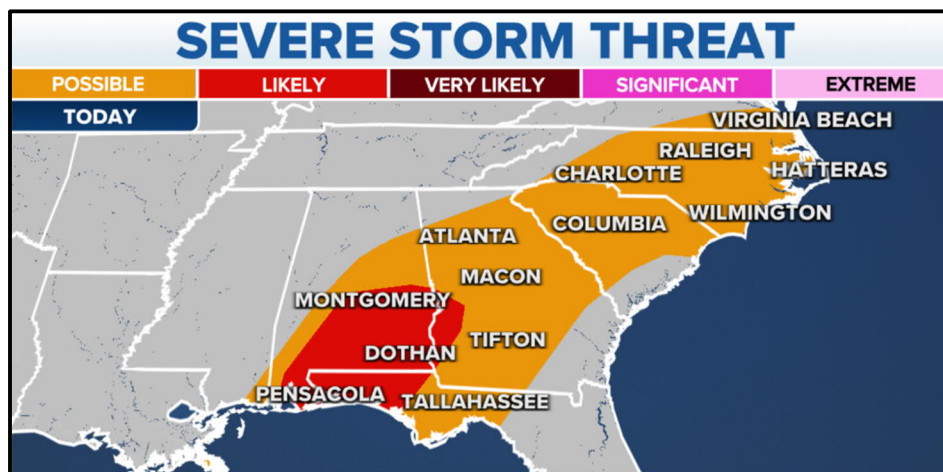
Atlantic – Disturbance 2

- Located over the central subtropical Atlantic.
- Conditions appear conducive to gradually acquire tropical characteristics.
- Formation chance – 48-hour: Low (20%); 7-day: Med (60%)



Severe Weather Outlook

- Thunderstorms began to erupt during the midday hours Monday and a number turned severe in the afternoon, spawning strong winds, hail and torrential downpours in central Louisiana.
- By the evening hours, some of these thunderstorms began to develop characteristics capable of producing tornadoes.
- Through Tuesday morning, there have been at least five preliminary reports of tornadoes across central portions of Louisiana and Mississippi, according to the Storm Prediction Center.
- A broad area of showers and thunderstorms is ongoing across the Southeast, prompting an occasional warning from the NWS.
- A few tornadoes are possible across south Alabama and the Florida Panhandle through Tuesday morning and into early Tuesday afternoon.
- The risk of damaging winds and a couple of brief tornadoes will also spread farther north and east Tuesday afternoon into Georgia, the Carolinas and far southern Virginia. This threat will continue through the overnight hours and into early Wednesday morning.

Declaration Activity

DR 4749 Illinois

- On November 20th, President Joseph R. Biden, Jr. declared that a major disaster exists in the State of Illinois and ordered Federal assistance to supplement state and local recovery efforts in the areas affected by severe storms and flooding from September 17 to September 18, 2023.
- The President’s action makes Federal funding available to affected individuals in Cook County.
- Additional designations may be made at a later date if requested by the state and warranted by the results of further damage assessments.
- On September 17, severe storms passed through Cook County producing heavy rainfall, flash flooding, and nine inches of precipitation resulting in significant property damage with widespread power outages and blocked roadways.
- On October 27, 2023, Governor Pritzker issued a disaster proclamation for Cook County due to severe weather and flooding on September 17, 2023.
- On November 7, 2023, Governor Pritzker submitted a request for a major disaster declaration for Individual Assistance for Cook County.
