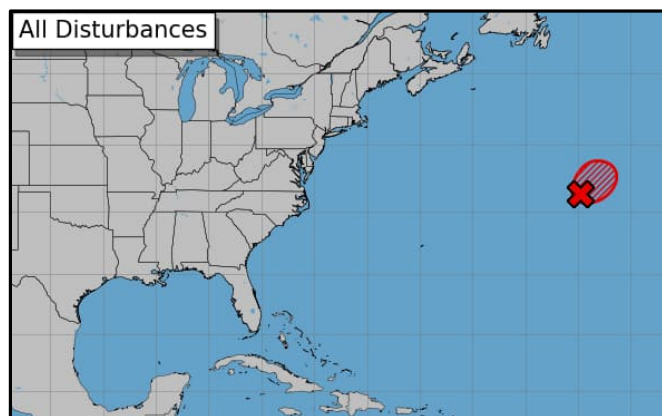

Tropical Activity

Atlantic – Disturbance 1

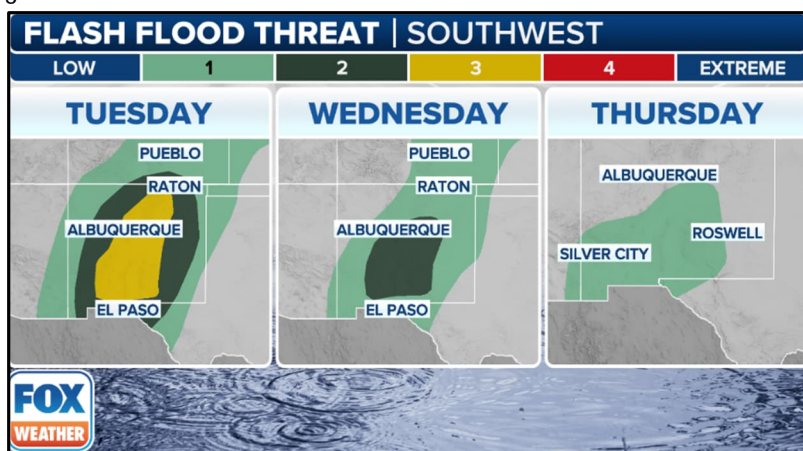
- The low-pressure system is located about 900 miles east-northeast of Bermuda.
- This system will likely become a short-lived tropical storm later today before more hostile environmental conditions end its opportunity for development by this evening.
- Forecasted to move northeastward at around 15 to 20 mph while remaining over the open central Atlantic.
- Formation chance through 48 hours – High (70%)
- Formation chance through 7 days – High (70%)



Flooding Activity

New Mexico

- Monsoon moisture led to storms that dumped heavy rain on burn scars left by the fires that ravaged Ruidoso last June.
- National Weather Service called out the Salt Burn Scar in a Flash Flood Warning that was issued for the area on Monday afternoon.
- Storm reports from the NWS showed U.S. Highway 70 was closed at Ruidoso Downs because of flooding.
- Reports also showed swift-water rescues were being conducted at a mobile home park and a hotel in nearby Hollywood, New Mexico.
- A greater flood risk is outlined in the state on Tuesday by NOAA's Weather Prediction Center.
- Zones cover much of central New Mexico, and forecasters have expressed concerns about burn-scar flooding across a wider area.

Disaster Declaration Request West Virginia

- On June 20, Governor Patrick Morrisey formally requested a Major Disaster Declaration and an Emergency Declaration in Ohio and Marion counties.
- On June 15, Governor Patrick Morrisey issued a State of Emergency.
- A slow-moving frontal system in combination with high levels of atmospheric moisture helped enable the development of significant localized rainfall and flash flooding.
- The stall system that caused this once in a century event dropped 2.5" to 4" of rainfall over a 30-to-40-minute period.
- About an hour to the southeast, heavy rains battered the Marion County community of Fairmont on June 15th, ripping off the outer wall of an apartment building and damaging bridges and roads.
- At least 60 homes, 25 businesses and an estimated 30 roads were impacted by flooding, Governor Patrick Morrisey said.
- Ohio County has experienced eight fatalities with one individual still missing.
