March 20, 2023

Heavy Rain & Flooding Activity <u>California</u>

- AccuWeather meteorologists warn that twin storms early this week can deliver another round of significant precipitation, first to Northern California, then through the southern part of the state.
- The first of these storms arrived Saturday evening. The rain spread across much of coastal Northern and Central California before working its way into interior sections. This particular storm delivered



rain through Sunday, as the heaviest precipitation shifted onshore early in the day.

- Following a soaking from this weekend's rainfall, the city of Santa Rosa, California, has officially received more than triple its historical average rainfall for the month of March. The city stands at a staggering 9.34 inches of rainfall as of March 20th when by this point in the month it typically picks up just under 3 inches.
- The second storm will drop in rather quickly on Tuesday. This will bring an even more robust round of rain and mountain snow into Wednesday, including a greater risk of dangerous flooding to Southern California.
- Unlike with the previous storm, a majority of the most robust tropical moisture from this event is likely to focus on Southern California.
- Heavy rain is expected to affect the Los Angeles metropolitan area on Tuesday, with widespread flooding possible on streets and in poor drainage areas.
- Cal Fire Damage Inspection Specialists completed their survey on Saturday of homes and businesses in Pajaro, after the levee breach.
- Crews inspected 858 buildings, according to George Nunez, the chief of Cal Fire's San Benito Monterey Unit.
- Cal Fire's damage assessment map shows three single-family homes were destroyed. Inspectors found some level of damage to 400 buildings, Nunez said.
