Tropical Activity <u>Atlantic – Disturbance 1</u>

- An area of low pressure could develop near the southeast U.S. Atlantic or Gulf coasts by this weekend along a weakening frontal boundary.
- Environmental conditions appear only marginally conducive for some slow development, but a tropical or subtropical depression could form in this region over the weekend or early next week while the system moves.
 - depression could form in this region over the weekend or early next week while the system moves. Regardless of development, heavy rainfall is possible across portions of the southeast U.S., particularly across the west-central Florida coast.

- Formation chance through 48 hours Low (0%)
- Formation chance through 7 days Medium (40%)

Wildfire Activity

<u>California</u>

- Fire season is in full swing across California, with more than a dozen wildfires igniting since Saturday.
- Most of the blazes are burning in the southern half of the state, where dry conditions are more extensive, allowing fires to quickly get out of hand.
- Hundreds of firefighters are working to contain wildfires in Riverside and San Bernardino counties, which have even forced evacuations.
- In Riverside County, the Wolf Fire has exploded in size after first being spotted over the weekend outside of Banning, California.
- As of Tuesday, according to CAL FIRE, more than 2,400 acres had burned, with containment only around 35%.
- More than 4,000 structures were considered threatened south of Interstate 10, with the American Red Cross establishing at least one shelter for evacuees.
- Further southwest, firefighters have made more progress with the Juniper Fire, which has burned nearly 700 acres but is more than 60% contained.
- Farther north, the Lake Fire in San Bernardino County is the one firefighters are most concerned about. At last check with CAL FIRE, the wildfire had burned nearly 500 acres and was around 50% contained.
