Tropical Activity Atlantic - Tropical Storm Fernand

- Forecasters are continuing to monitor strengthening Tropical Storm Fernand swirling over the open waters of the Atlantic
- Maximum sustained winds of 50 mph with some higher gusts, and some strengthening is possible on Monday before weakening is set to begin Monday night.
- Expected to become post-tropical on Wednesday.
- Currently located about 360 miles east-northeast of Bermuda, and was moving off to the north-northeast at 12 mph.
- The NHC said that Tropical Storm Fernand is expected to continue that motion for the next day or so, followed by a turn to the northeast.

Atlantic – Invest 99L

- The NHC had been monitoring Invest 99L over the warm waters of the Caribbean, but development chances for that system have dropped to zero.
- The NHC said that showers and thunderstorms associated with Invest 99L have remained disorganized, and further development is no longer expected.
- Despite that, portions of the Windward Islands could still see some gusty winds and rain on Monday as the system moves quickly to the west.
- Formation chance 48-hour: Low (0%); 7-day: Low (0%)

Disaster Declaration Request Illinois

- On August 21, Governor JB Pritzker issued a state disaster proclamation after severe weather and flooding caused extensive damage across Cook, Jersey, and Calhoun Counties from July 25-28, 2025.
- The Illinois Emergency Management Agency and Office of Homeland Security, in partnership with local government entities and the Federal Emergency Management Agency (FEMA), conducted joint Preliminary Damage Assessments (PDAs) between August 11-17, 2025, that confirmed widespread damages to communities.
- This severe storm system caused substantial flooding, resulting in significant property damage, widespread power outages, and blocked roadways that impacted homeowners, businesses, utilities, and local governments.
- The flooding also disrupted transportation networks as flash flooding and debris limited access to roadways, while extended power outages further hindered recovery and response efforts.
- Officials said the storms destroyed more than 100 homes. Several hundred more experienced major damage, and thousands more were affected.
