



December 8, 2025

Flood Threat Pacific Northwest

- A strong atmospheric river of moisture will surge into the Pacific Northwest, bringing heavy rain and a threat of flooding to western Washington and Oregon through late this week.
- Flood watches are already in effect for western Washington, northwest Oregon and parts of northern Idaho and far western Montana much of this week.
- The first round of rain kicks off Monday and continues into early Tuesday, when the atmospheric faucet really turns on and rainfall rates of an inch per hour are possible. This could lead to totals potentially reaching 5 inches across the coast and the Cascades.
- Winds will also be strongest with this first round. Widespread gusts to 30 mph with isolated gusts over 40 mph could bring down tree limbs and take out power lines.
- The next round of moisture will surge on-shore Tuesday night into Wednesday. While this surge isn't currently forecast to be as strong, soil will be saturated after the first round, so flooding will become increasingly more widespread, especially in the foothills of the Cascades.
- Widespread rainfall amounts of 3 to 6 inches are possible by the end of the week, with higher elevations in the Cascades potentially seeing 6 to 12 inches.
- Along the Seattle-Tacoma and Portland-Salem-Eugene corridors, this could lead to flash flooding at times, particularly in areas most prone to street and urban flooding.
- The bigger concern, however, is for potentially major river flooding in the Cascades and foothills of western Washington as water from both heavy rain and melting snow swells rivers and streams.
- The National Weather Service is currently forecasting river flooding in three dozen locations this week in the Northwest, with major flooding possible along stretches of the Cowlitz, Nisqually, Puyallup, Skagit, Skykomish and Tolt rivers.
