Severe Weather Outlook

- A dangerous outbreak of severe thunderstorms today could produce strong tornadoes, destructive straightline winds and large hail as flooding rain takes aim at the Ohio Valley.
- A broad area of rain and thunderstorms stretches from Texas to the Ohio Valley this morning.
- A severe thunderstorm watch is in effect for north-central Texas until 9 a.m. CT.



- An outbreak of severe storms is expected in the South during the afternoon and evening hours, especially across parts of the lower Mississippi Valley.
- This includes Shreveport and Monroe, Louisiana; Greenville and Jackson, Mississippi; Memphis, Tennessee; and Little Rock, Arkansas.
- Supercell thunderstorms and a squall line of severe storms could impact parts of this region and produce tornadoes, large hail and wind damage. This might include the possibility of strong tornadoes (EF2 or greater strength).
- A few of the tornadoes that develop could become strong and long-tracked, threatening multiple communities.
- The chance of severe weather will generally advance from west to east across the severe weather risk areas shown below from this afternoon into the overnight hours.
- The setup is also one that can wring out heavy rain in a short amount of time.
- Flooding incidents were already ramping up from Thursday night to Friday morning from parts of Oklahoma to portions of Indiana and Ohio.
- Multi-inch rainfall totals are possible from the Ohio Valley into the mid-Mississippi Valley and mid-South through Friday night.



 As a result, the National Weather Service has issued flood watches from the eastern half of Oklahoma to the Ohio Valley.
