Tropical Activity Atlantic – Disturbance 1

- An area of low pressure in the northern Atlantic Ocean is being tracked by the National Hurricane Center for the possible formation of the season's first tropical depression or storm.
- The low-pressure system is located about 500 miles east of Bermuda and has become better organized since the NHC began tracking it on Sunday.
- This system's window of opportunity to develop is small since environmental conditions become increasingly hostile by Tuesday.
- The good news is that since the system's location is far from land and is no threat to the United States or anywhere else.



• On average (1991-2020), the first Atlantic storm of the season has formed by June 20, so if Andrea develops out of this disturbance it'd be right on time.

Severe Weather Activity North Dakota

- A deadly tornado impacted rural Cass County, North Dakota, at 23:40 LT on June 20.
- Governor Kelly Armstrong declared a statewide disaster following the deadly storm.
- The Cass County Sheriff's Office confirmed three fatalities in the area near Enderlin.
- The severe thunderstorms and tornadoes caused significant damage to homes and infrastructure in several parts of eastern North Dakota, including Urbana, Eckelson, and Buchanan.
- The Enderlin tornado was part of a broader outbreak of severe weather affecting southeastern North Dakota and western Minnesota.
- The NWS received reports of tornadoes in Cass, Barnes, Ransom, and Stutsman counties.
- Wind gusts associated with the storm system reached up to 111 mph near Luverne, North Dakota, and 106 mph in Bemidji, Minnesota.
- Storms also produced large hail, measured over 3.5 inches in diameter, and led to flash flooding, particularly in Fargo and Bemidji, according to local reports.
- Power outages peaked at over 30,500 customers in southeastern North Dakota. As of June 21, outages had been reduced to 22,876 customers.
